#### FINANCIAL IMPACT:

No additional financial impact. The final retainage payment is authorized 30 days after Board Acceptance as provided for in the construction contract. The retainage amount is \$11,789.81.

#### **SUMMARY:**

This action formally accepts this project as outlined in the construction project minutes attached. This contract is for extension of fee district water main to serve the Westport Development. The work was done by Elder Corporation, of Des Moines, Iowa.

#### **BACKGROUND:**

In January 2017, the West Des Moines Water Works awarded a contract to Elder Corporation in the amount of \$217,566.90. It has been completed in accordance with the plans and specifications prepared by Engineering Resource Group. It was inspected by the Water Works staff during the construction process. Based on the final quantities of work required by the project, the final construction cost is \$235,796.30. Other costs include engineering costs of \$5,918.00, easement costs of \$27,539.49 and miscellaneous costs of \$1,624.00 for a total project cost of \$270,877.79.

#### A RESOLUTION ACCEPTING COMPLETED CONSTRUCTION

WHEREAS, on the thirtieth day of January, 2017, The West Des Moines Water Works entered into a construction contract with

#### Elder Corporation of Des Moines, Iowa

2016 Southwest Area Fee District Water Main Extension – Mills Civic Parkway from Wendover Road to Grand Prairie Parkway (West Des Moines Water Works Project No. 00800-170-16007) **WHEREAS**, said contractor has substantially completed the construction of said public improvements in substantial accordance with the terms and conditions of said Contract and the Plans and Specifications for said project, and;

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE WEST DES MOINES WATER WORKS, AS FOLLOWS:

Section 1. That said report of the General Manager be and the same is hereby approved and adopted and said public improvements are hereby approved and accepted as having been fully completed in accordance with said Plans and Specifications and Form of Contract. The total final construction cost thereof is hereby determined to be \$235,796.30, and the total final project cost thereof is hereby determined to be \$270,877.79 of which amount includes engineering costs of \$5,918.00, easement costs of \$27,539.49 and miscellaneous costs of \$1,624.00.

Section 2. That the amount of \$11,789.81 is approved for payment to the contractor in accordance with the terms of the Contract.

Section 3. That the Contractor's maintenance bond shall expire on the sixteenth of October, 2021, which date is four years after the date of the acceptance of said public improvements by The Board of Trustees of the West Des Moines Water Works.
