PROCEEDINGS OF THE BOARD OF TRUSTEES OF THE WEST DES MOINES WATER WORKS

November 20, 2017

The regular meeting of The Board of Trustees of the West Des Moines Water Works was called to order by Chair Karen Novak Swalwell at 4:04 p.m. on Monday, November 20, 2017. Trustees Jody Smith, Brian Rickert and Gretchen Tegeler were present; also present were staff members Diana Wilson, General Manager; Paula R. Meyer, Finance Manager and Treasurer; Becky Scott, Finance Manager and Treasurer; Mark Hanasz, Water Distribution Manager; William Mabuce, Engineering Project Manager; Mitch Pinkerton, Water Production Manager; and Josh Heggen, Business Relations Manager. Tom Hadden, West Des Moines City Manager, attended on behalf of the West Des Moines City Council as liaison to the Board.

Moved by Tegeler, seconded by Smith that the agenda be approved. Roll call: All yes. Motion carried.

No one came forward during the Citizen Forum.

Moved by Rickert, seconded by Tegeler to receive and file the Monthly Financial Report for October 2017.

The Chair announced that this is the time and place fixed for a public hearing on the matter of the 2018 Water and Basic Service Charge Rate Adjustments. The Secretary reported that the Notice of Public Hearing was published in the *Des Moines Register*, *Saturday, November 11, 2017*, and the affidavit of publication is available to file with The Board of Trustees. The Chair called for any oral objections to the water and basic service charge rate adjustments. No oral objections were offered and the Secretary reported that no written objections thereto had been filed. Hearing no further comments, the Chair declared the public hearing closed.

Recently, the group has discussed the topic of equity contributed to the Des Moines Water Works production assets from regional partners and the amount and value of unsubscribed capacity. Ms. Brown spoke about her difficulty in paying her water bill due to personal struggles. The Customer and Community Relations Committee will discuss her situation and respond.
