**SUMMARY:**

This action formally accepts the West Des Moines Water Works General Supplemental Specifications to the Iowa Statewide Urban Standard Specifications for Public Improvements Manuals (SUDAS) for water main installation within the service territory of the Water Works.

It will replace the General Supplemental Specifications to SUDAS last adopted by the Board in January 2017.

**BACKGROUND**

The Iowa Statewide Urban Standard Specifications for Public Improvements Manual (SUDAS) was adopted by the Board in November 2015. At that time, the Board also adopted West Des Moines Water Works General Supplemental Specifications to SUDAS.

The SUDAS manuals are updated annually. The updated General Supplemental Specifications reflect the annual SUDAS revisions.
