FINANCIAL IMPACT:

No additional financial impact. The final retainage payment is authorized 30 days after Board Acceptance as provided for in the construction contract. The retainage amount is \$4,226.39.

SUMMARY:

This action formally accepts this project as outlined in the construction project minutes attached. This contract is for remedial work required on the 2016 Water Main Replacement Project to complete work left unfinished by the original contractor. The work was done by J&K Contracting, LLC.

BACKGROUND:

In November 2016, the West Des Moines Water Works awarded a contract to J&K Contracting, LLC in the amount of \$73,067.50. It has been completed in accordance with the plans and specifications prepared by WDMWW staff. It was inspected by the Water Works staff during the construction process. Based on the final quantities of work required by the project, the final construction cost is \$84,527.74. Other costs include miscellaneous costs of \$10,523.06 for a total project cost of \$95,050.80.
