A RESOLUTION ACCEPTING PERMANENT ACCESS EASEMENT FOR WATER MAIN AND APPURTENANCES

WHEREAS, Hubbell Metropolitan Development Fund I, LLC (Series B), Aventura at Greenway Crossing, LLC, and New Horizon Real Estate Development- Iowa, LLP, have granted an easement for water main and appurtenances to the West Des Moines Water Works, and

WHEREAS, documents conveying the easements have been signed by the property owners and are presented to the Water Works for approval; and

WHEREAS, the acquisition of this easement will allow the West Des Moines Water Works to access, operate and maintain the private water main located outside the platted right-of-way for this development.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE WEST DES MOINES WATER WORKS, AS FOLLOWS:

That said water main easement is hereby accepted by the West Des Moines Water Works to allow for construction and operation of water distribution system facilities.

PERMANENT ACCESS EASEMENT FOR WATER MAIN AND APPURTENANCES

KNOW ALL MEN BY THESE PRESENTS:

THAT Hubbell Metropolitan Development Fund I, LLC (Series B), Aventura at Greenway Crossing, LLC, and New Horizon Real Estate Development- Iowa, LLP, hereinafter referred to collectively as the Grantor, in consideration of the sum of one and no/100 Dollar (\$1.00), in hand paid by the City of West Des Moines, Iowa, an Iowa Municipal Corporation, acting through its Board of Water Works Trustees, hereinafter referred to as City, receipt of which is hereby acknowledged, does sell, grant and convey to the City a permanent water main easement (hereinafter called "Easement") upon, over, under, through, and across the following described real property, and also including the right of ingress and egress over adjoining lands of Grantor, to wit:

A PERMANENT PRIVATE WATER EASEMENT 10 FEET ON EITHER SIDE OF THE FOLLOWING DESCRIBED CENTERLINE OR CENTERLINE EXTENDED, BEING PART OF LOTS 1, 2, 3, 10 AND 11 OF GREENWAY CROSSING PLAT 1, AN OFFICIAL PLAT LOCATED IN AND FORMING A PART OF THE CITY OF WEST DES MOINES, DALLAS COUNTY, IOWA.

COMMENCING AT THE SOUTHEAST CORNER OF SAID LOT 3; THENCE, ALONG THE EAST LINE OF SAID LOT 3, N00°20'02"E, 92.48 FEET TO THE POINT OF BEGINNING; THENCE S30°06'58"W, 97.92 FEET; THENCE N89°39'58"W, 490.10 FEET TO THE POINT OF TERMINATION. DESCRIBED AREA CONTAINS 11,800 SQUARE FEET AND IS SUBJECT TO EASEMENTS AND RESTRICTIONS OF RECORD.

to permit and allow the City, and others working on its behalf, to enter at any time upon and into the easement area described herein, and to use as much of the surface and subsurface thereto as is reasonably needed to operate whenever necessary, the water main and appurtenances thereto within the easement area granted herein, but for no other purpose or use whatsoever.

THAT the within easement grant shall run with the land and be binding upon the heirs, assignees and transferees of the Grantor herein and shall be permanent unto the City.

EACH GRANTOR covenants with the City that it holds its portion of the above described real property by good and perfect title, free and clear of all liens and encumbrances and that the Grantor has a good right and lawful authority to make and execute this Easement herein. Grantor warrants and defends the portion of this Easement located on its property against the lawful claims of all persons.
