FINANCIAL IMPACT:

No additional financial impact. The final retainage payment is authorized 30 days after Board acceptance as provided for in the construction contract. The final construction cost of this project is \$23,942.00.

SUMMARY:

This action formally accepts this project as outlined in the construction project minutes attached. The work was done by The Underground Company, Ltd.

BACKGROUND:

In November 2021, the West Des Moines Water Works awarded a contract to The Underground Company, Ltd. of Carlisle, Iowa in the amount of \$25,000 for the off-site sanitary sewer connection for the Adams Street Elevated Water Storage Tank. It has been completed in accordance with the plans and specifications prepared by Veenstra & Kimm. Veenstra & Kimm and WDMWW provided construction observation on this project. The project was also inspected by the City of West Des Moines since they will take ownership of this pipe upon City acceptance. Based on the final quantities of work required by the project, the final construction cost is \$23,942.00. Other costs include miscellaneous costs of \$203.64 for a total project cost of \$24,145.64.

The City of West Des Moines plans to accept this sanitary sewer into their system at an upcoming council meeting.

WHEREAS, said contractor has substantially completed the construction of said public improvements in substantial accordance with the terms and conditions of said Contract and the Plans and Specifications for said project,

**NOW, THEREFORE, BE IT RESOLVED
BY THE BOARD OF TRUSTEES OF THE WEST DES MOINES WATER
WORKS, AS FOLLOWS:**

Section 1. That said report of the General Manager be and the same is hereby approved and adopted and said public improvements are hereby approved and accepted as having been fully completed in accordance with said Plans and Specifications and Form of Contract. The total final construction cost thereof is hereby determined to be \$23,942.00, and the total final project cost thereof is hereby determined to be \$24,145.64 of which amount includes miscellaneous costs of \$203.64.

Section 2. That the Contractor's maintenance bond shall expire on the 20th day of April 2026, which date is four years after the date of this Resolution and acceptance of said public improvements by the Board of Trustees of the West Des Moines Water Works.
