FINANCIAL IMPACT:

No additional financial impact. The final retainage payment is authorized 30 days after Board acceptance as provided for in the construction contract. The retainage amount is \$85,220.00.

SUMMARY:

This action formally accepts this project as outlined in the construction project minutes attached. The work was done by Synergy Contracting of Altoona, Iowa.

BACKGROUND:

In July 2022, the West Des Moines Water Works awarded a contract to Synergy Contracting, LLC of Altoona, Iowa in the amount of \$1,482,629.00. It has been completed in accordance with the plans and specifications prepared by HR Green, Inc. Based on the final quantities of work required by the project, the final construction cost is \$1,704,400.09. Other costs include easement costs of \$53,862.00 and miscellaneous costs of \$10,185.39 for a total project cost of \$1,768,447.48. Engineering costs are \$663,953.70 to date for design and construction services on Segment 1, Segment 2 (this project) and the remaining segments of the overall project from Valley West Drive to 8th Street.

WHEREAS, on the twentieth day of July, 2022, The West Des Moines Water Works entered into a construction contract with

Ashworth Road Water Main Replacement –
Valley West Drive (35th Street) to 31st Street and 11th Street to 8th Street
(Water Works Project No. 00800-120-21011)

and,

WHEREAS, said contractor has substantially completed the construction of said public improvements in substantial accordance with the terms and conditions of said Contract and the Plans and Specifications for said project,

**NOW, THEREFORE, BE IT RESOLVED
BY THE BOARD OF TRUSTEES OF THE WEST DES MOINES WATER
WORKS, AS FOLLOWS:**

Section 1. That said report of the General Manager be and the same is hereby approved and adopted and said public improvements are hereby approved and accepted as having been fully completed in accordance with said Plans and Specifications and Form of Contract. The total final construction cost thereof is hereby determined to be \$1,704,400.09, and the total final project cost thereof is hereby determined to be \$1,768,447.48 of which amount includes easement costs of \$53,862.00 and miscellaneous costs of \$10,185.39. Engineering costs are \$663,953.70 to date for design and construction services on Segments 1, 2 (this project) and the remaining segments.

Section 2. That the Contractor's maintenance bond shall expire on the sixteenth day of October 2027, which date is four years after the date of the acceptance of said public improvements by The Board of Trustees of the West Des Moines Water Works.
